### "MUNICIPAL ORDINANCE NO. 001-2017

# AN ORDINANCE PROHIBITING THE STOCKPILING OF SAND, GRAVEL AND QUARRY MATERIALS IN MUNICIPALITY STREET OF TRENTO, AGUSAN DEL SUR

### Sponsor: Hon. Edcil Marie D. Pagayon

WHEREAS, there are constituents in the municipality of Trento stockpiling sand, gravel and quarry materials in the streets, roads, sidewalk, driveway and any other access to roads;

WHEREAS, the said stockpiling causes nuisance and traffics specifically to drivers which blocked channel of road;

WHEREAS, it is vital to create a policy to regulate stockpiling of sand, gravel and quarry materials;

NOW THEREFORE, be it ordained by the Sangguniang Bayan in session assembled that:

**SECTION 1.** *Title.* An ordinance prohibiting the stockpiling of sand gravel and quarry materials in the streets, roads, sidewalk, driveway and any other access to road in the municipality of Trento.

**SECTION 2.** It shall be unlawful for any lessee, owners or occupant of any lot that stockpile sand, gravel and quarry materials in the streets, roads, sidewalk or driveway in the municipality of Trento in such manner which obstructs, impede or in any way hampers pedestrians or vehicular traffic, is hereby declared to be nuisance.

#### SECTION 3. Definition of Term.

**Owner** – a person, corporations, partnership, association, company and any other entities owning the sand, gravel and quarry materials for a specific purpose.

**Sand** – is a naturally occurring granular material composed of finely divided rock and mineral particles. It is **defined** by size, being finer than **gravel** and coarser than silt.

Gravel - An unconsolidated mixture of rock fragments or pebbles.

**Quarry** - is a place from which dimension stone, rock, construction aggregate, riprap, **sand**, **gravel**, or slate has been excavated from the ground. A **quarry** is the same thing as an open-**pit mine** from which minerals are extracted.

**Vehicular Traffic** – the aggregation of things (pedestrians or vehicles) coming and going in a particular locality during a specified period of time.

**SECTION 4.** *Penalty Clause.* If an owner of the lot, lessees or occupants stockpile sand, gravel and quarry materials in the roads, streets, sidewalk, driveway and any other access to road, for construction without delay or other purposes is hereby given one (1) month duration to remove and use the materials.

If notice that no uses made of the sand, gravel and quarry materials for its purpose after placing in the streets, roads, sidewalk, driveway and any other access to road after one (1) week will be automatically subject for a fine of Five Hundred Pesos (Php500.00).

If the subject sand, gravel and quarry materials are not still used by the owner after one (1) week of penalty, will be confiscated or removed automatically.

**SECTION 5.** Repealing Clause. All ordinances, local issuances or rules inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 6. Effectivity Clause. This Ordinance shall be effective upon approval thereof.
