**"MUNICIPAL ORDINANCE NO. 002 - 2017**

**AN ORDINANCE ALLOWING THE PUBLIC TO USE RM BILLANES GYM EVERY TUESDAY, THURSDAY AND SATURDAY FROM 6PM TO 9PM FOR FREE**

WHEREAS, many of our constituents wish to engage into sports activities during their pleasure time but find no vacant period during daylight since some of them are students or workers, thus they only have their free time during after classes and works which only falls during night time;

WHEREAS, the R.M. Billanes Gym is a municipal establishment designed to hold activities including sports;

WHEREAS, this municipality recognizes the importance of sports in the holistic development of a person and instilling the values of sportsmanship and active lifestyle among the constituents, especially the youth;

WHEREFORE, on motion by Hon. John Arbee A. Agcopra and duly seconded by Hon. Permita B. Lamberto, be it Ordained by the Sangguniang Bayan in session assembled that:

SECTION 1. This ordinance shall allow the public for a free usage of the municipal gymnasium from 6:00 o'clock PM to 9:00 o'clock PM.

SECTION 2. **PURPOSE.** Proactive sports development programs keep the youth away from dangerous drugs, gangs and other counter-productive and dangerous activities.

SECTION 3. **PERMISSION TO USE.** Any person, group or organization must seek permission first to the personnel-in-charge of the gymnasium for record purposes and be oriented on the use of the gymnasium.

SECTION 4. **PROHIBITED ACT. The following is prohibited when inside the gymnasium:**

- a. No person shall dispose garbage/wastes inside the gymnasium.
- b. He/she is prohibited to do acts which will cause damage to the properties inside the gymnasium.

SECTION 5. **SEPARABILITY CLAUSE.** If, for any reason or reasons, any part or provision of this Ordinance shall be found unconstitutional or valid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and in effect.

SECTION 6. **REPEALING CLAUSE.** All which ordinances and other municipal issuances, or any part or parts thereof, which are inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

SECTION 7. **EFFECTIVITY CLAUSE.** This ordinance shall take effect upon approval hereof.
