## "MUNICIPAL ORDINANCE NO. 015 Series of 2017

AN ORDINANCE AMENDING SECTION 10 AND SECTION 11 OF MUNICIPAL ORDINANCE NO. 016-2012 "AN ORDINANCE PRESCRIBING THE DAY, TIME AND PLACE OF THE "TABO" OPERATION AND PROMULGATING RULES AND REGULATIONS THEREOF

Be it Ordained by the Sangguniang Bayan in session assembled that:

SECTION 1. Section 10 of Municipal Ordinance No. 016-2012 is hereby amended as follows:

Setion 10. All tabo vendors are required to provide their own table and shall start to arrange their tables in the taboan site at 3:00 AM of Saturday. And all tables shall be pulled out at the taboan site before 3:00 o'clock AM, Sunday.

SECTION 2. Section 11 of Municipal Ordinance No. 016-2012 is hereby amended as follows:

Section 11. Every vendor is responsible in cleaning its rental space. Garbage shall be put in a plastic bag or container and they shall bring it with them upon leaving their respective rented area/space.

- SECTION 3. Municipal Ordinance No. 016-2012, as amended by Municipal Ordinance No. 015-2017 shall now read as follows:
  - **Section 1.** The promulgation of the "Tabo" operation "Market Day" is in accordance to Sec. 2242 of the Revised Administrative Code of 1987.
  - **Section 2.** Pursuant to Section 447 of R.A. 7160 as amended: It is the power and duty of Sangguniang Bayan to regulate any business operations within its municipal jurisdiction; to attain a smooth and orderly business environment.
  - Section 3. The Market Day "Tabo" shall start from 2:00 o'clock A.M. of every Saturday until 7:00 o'clock P.M. of the same day. The Tabo Operation shall be allowed even during legal holidays.

## Section 4. Implementing Rules and Regulations:

- 4a. All Tabo Vendors shall be required to secure a Mayor's Permit from the Municipal government. No Permit, No Vending.
- 4b. Requirements for the application of Mayor's Permit.'
  - a) Community Tax Certificate
  - b) Health Clearance
  - c) Barangay Clearance
  - d) Police Clearance
  - e) Garbage Fee
- **Section 5. Sectioning.** Shall be in accordance to the commercial items/goods sold. The items/goods shall be displayed/sold at the official designated specific place/street for their section.
- Section 6. Sections and their designated street/place are as follows:

a) RTW (ukay-ukay, shoes, caps, & blankets)

Market Drive # 1 & 2

From R.M. Billanes St. to Juan Luna St.

b) Chichiria, Plastic wares

Market Drive # 2

From R.M. Billanes St. to Antonio Luna St.

Salted Fish/ dried Fish

Market Drive # 1

Banana/ Root crops

Along Antonio St. (from Rizal St. to

Market Drive # 1)

e) Fish, shells & Seaweeds

Market Drive # 4

Dressed Chicken & Lechon (Pig) -

Market Drive # 4

Vegetables

Along Sergio Osmeña St. (from Antonio

Luna St. to Juan Luna St.)

h) Fruits

Market Drive # 3

Section 7. No vendors shall be allowed to sell/display their commercial items/goods outside their designated street/place.

Section 8. No mobile vendors are allowed.

Section 9. Every Fish Vendor shall be allowed to display Four (4) Banyeras of Fish only.

Section 10. All tabo vendors are required to provide their own table and shall start to arrange their tables in the taboan site at 3:00 AM of Saturday. And all tables shall be pulled out at the taboan site before 3:00 o'clock AM, Sunday.

Section 11. Every vendor is responsible in cleaning its rental space. Garbage shall be put in a plastic bag or container and they shall bring it with them upon leaving their respective rented area/space.

Section 12. A one meter wide passage way shall be provided right at the center of the road in all sections except, the fish section that needs to be two (2) meters wide.

Section 13. Penal Provision. Any person, natural or juridical found violating this ordinance shall be penalized as follows:

First Offense

Fine of Five hundred Pesos (₱ 500.00)

Second Offense

Fine of One Thousand Pesos ( 1,000.00)

Third Offense

Confiscation of items/goods and cancellation of Mayors

Permit, banned from displaying during tabo

Section 14. Separability Clause. If, for any reasons or reasons, any part or provision of this ordinance shall be found unconstitutional or invalid, other parts or provisions hereof which are not effected thereby shall continue to be in full force and in effect.

Section 15. Repealing Clause. All local laws, rules and regulations inconsistent with this Ordinance are hereby deemed repealed/amended accordingly.

Section 16. Effectivity Clause. This Ordinance shall be effective upon approval thereof.
