"MUNICIPAL ORDINANCE NO. 017 Series of 2017

AN ORDINANCE REGULATING THE PUTTING UP OF SIGNAGE OF CHEMICALS AND FERTILIZERS WITHIN THE MUNICIPALITY OF TRENTO

Sponsor: Hon. George G. Diel

WHEREAS, Trento, Agusan del Sur is known as authentic organic capital in the region as seen in the Municipality's Vision and Mission;

WHEREAS, to strengthen the Trento's Vision on Organic farming; hence

WHEREAS, there is a need to regulate the putting of signage's or any advertisement materials for INORGANIC PESTICIDES AND HERBICIDES and other such materials for agricultural purposes products;

WHEREFORE, on motion by Hon. George G. Diel and duly seconded by Hon. Rose P. Mabunga, be it

ENACTED BY THE SANGGUNIANG BAYAN IN SESSION ASSEMBLED THAT:

Section 1. This ordinance is hereby enacted to regulate the *putting of signage of advertisement materials for INORGANIC Pesticides and Herbicides and other such materials for agricultural purposes products.*

Section 2. **Permissible.**- The putting of signage shall follow these rules:

| A. For National Highways: | 200 meters from the center of the road. |
| B. For Provincial and Barangay roads: | 100 meters from the center of the road. |

Section 3. **Prohibitions.**- **Nailing of signage or any advertisements on trees are strictly prohibited.**

Section 4. A permit from the Municipal Government shall be secured first before the putting up of any signage or advertisement.

Section 5. **Penalty.**- Violations thereof shall be penalized as follows:

First Offense	-	P 500.00
Second Offense	-	P 1,000.00
Third Offense	-	P 1,500.00 or Imprisonment upon discretion of the Court

Section 6. **Separability.** - Should any provision of this ordinance be declared by a court of competent jurisdiction to be illegal, unconstitutional or invalid the other provisions not so affected shall remain valid and effective.

Section 7. **Repealing Clause.** - All which ordinances and other municipal issuances, or any part or parts thereof, which are inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

Section 8. **Effectivity.** - This ordinance shall take effect immediately upon approval hereof.
