"MUNICIPAL ORDINANCE NO. 018 Series of 2017

ORDINANCE REQUIRING ALL BUSINESS ESTABLISHMENTS TO HANG STREAMERS SUPPORTING THE SANTIKAN FESTIVAL

Sponsor:

Hon. George Diel

- SECTION 1. All business establishments are required to hang streamers the Santikan Festival.
- SECTION 2. All public utility tricycles and cabless motorcycles are required to install flaglets supporting the Santikan Festival.
- SECTION 3. Streamers and flaglets shall bear the following text:

"Mabuhay Santikan Festival 20 __!"

- SECTION 4. Streamers and flaglets shall be either in green, yellow or a combination of both.
- SECTION 5. Materials. Streamers/flaglets may be made of tarpaulin, katsa, cartolina. But sack and similar materials shall not be allowed.
- SECTION 6. Size. There is hereby prescribed a minimum size for streamers and flaglets as follows:

Streamers:

rectangle with the dimension of 1 foot by

2 feet (1x2 ft)

Flaglets:

right triangle with a length of 13 inches

and width of 8.5 inches

- SECTION 7. Streamers and/or Flaglets shall be installed not later than September 7. Penalty and sanctions shall start on September 8.
- SECTION 8. Penalty. Violators shall be penalized as follows:

First Offense

P 500.00

Second Offense

P 1,000.00

Third Offense

P 1,500.00 or imprisonment

Upon discretion of the Court

- Section 10. Repealing Clause All Ordinance, Resolutions, Orders, Memoranda and other Issuances inconsistent herewith are hereby amended, repealed or modified accordingly.
- Section 11. Separability Clause If, for one reason or another, some part of this Ordinance is found to be invalid or unconstitutional, all other provisions hereof not affected thereby shall remain to be in full force and effect.
- Section 12. Effectivity. This Ordinance shall take effect immediately after the public hearing and approval.
