### **"MUNICIPAL ORDINANCE NO. 027 Series of 2017**

**AN ORDINANCE AUTHORIZING TEMPORARY FULL CLOSURE OF CARLOS P. GARCIA STREET FROM SEPTEMBER 18, 2017 TO OCTOBER 5, 2017 DURING SANTIKAN FESTIVAL AND PAROCHIAL FIESTA**

WHEREAS, Section 21 of the Local Government Code provides that:

- a) A local government unit may, pursuant to an ordinance permanently or temporarily close or open any local road, alley, park or square falling within its jurisdiction.."
- b) Any national or local road, alley, park or square may be temporarily closed during an actual emergency, or fiesta celebrations.. the duration of which shall be specified by the local chief executive concerned in a written order.."

WHEREAS, Trento shall celebrate the Santikan 2017 on September 18, 2017 followed by the Catholic Celebration of the Feast Day of St. Francis of Assisi on October 5, 2017;

WHEREAS, during this period, there is an increase in economic activity in the municipality with the proliferation of small enterprises;

WHEREAS, to avoid inconvenience to the public and to ensure full implementation of rules and regulations on economic enterprise as well as on peace and order, there is a need to designate a specific place for these seasonal business activities;

NOW THEREFORE, BE IT ENACTED, AS IT IS HEREBY ENACTED, BY THE SANGGUNIANG BAYAN OF TRENTO, AGUSAN DEL SUR, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, IN SESSION ASSEMBLED THAT:

**Section 1.** The Carlos P. Garcia St. is hereby declared temporarily closed to all vehicular traffic from September 18, 2017 to October 5, 2017.

**Section 2. EFFECTIVITY CLAUSE.** This Ordinance shall take effect upon approval thereof.
