AN ORDINANCE REQUIRING ALL MOTORIZED TRICYCLE OPERATORS WITHIN THE MUNICIPALITY OF TRENTO TO PUT THE NAME OF THE OPERATOR IN BOTH SIDES OF THEIR TRICYCLE

WHEREAS, a progressive town like Trento is dependent upon the existence of a balance, adequate and efficient transportation system that includes the tricycle for hire in its day to day economy being a developing municipality;

WHEREAS, the Sangguniang Bayan needs to impose the putting of Operator's Name on every Motorized Tricycle and tricycle-for-hire operating within the jurisdiction of Trento in order to ensure smooth operation and uniformity of tricycles plying within the municipality;

WHEREAS, on motion by Hon. George G. Diel and duly seconded by Hon. Rose P. Mabunga, be it;

ENACTED BY THE SANGGUNIANG BAYAN SESSION ASSEMBLED THAT:

SECTION 1. This ordinance shall be known and referred to as **"AN ORDINANCE REQUIRING ALL MOTORIZED TRICYCLE OPERATORS WITHIN THE MUNICIPALITY OF TRENTO TO PUT THE NAME OF THE OPERATOR IN BOTH SIDES OF THEIR TRICYCLE"**.

SECTION 2. PROCEDURE OF THE ENFORCEMENT OF THE PUTTING OF THE OPERATOR'S NAME. Every tricycle registered in the municipality of Trento shall bear the name of the operator (4 inches x 12 inches) in both sides of their tricycle.

A Franchise case number should also be legibly printed in bold black letters (1 inch x 5 inches) in the body of the tricycle (specifically in front and rear) including the address, contact number and the capacity of its passengers.

SECTION 3. PROHIBITIONS

The following constitute prohibitions in the operation of the motorcycle-for-hire:

- A. Stickers, paintings and other adornments that hamper the proper viewing of the distinctions of the motor vehicles particularly the name and address of the operator and passenger's capacity.
- B. Lewd designs, markings and drawing in the tricycle.

SECTION 4. PENAL PROVISION. Violations committed relative to the implementation of this ordinance shall be penalized in the following manner:

- A. Any operator (natural or juridical) who fails to put their name on their tricycle as stipulated in section 2 of this ordinance shall be meted with the following penalties:

First Offense	- a fine of One Thousand Pesos (P1,000.00)
Second Offense	- a fine of Two Thousand Pesos (P2,000.00)
Third Offense	- a fine of Two Thousand Five Hundred Pesos (P2,500.00) Cancellation of business permit and permanent ban on future applications.

- B. Any operator (natural or juridical) who violated other provisions of this ordinance shall be meted with the following penalties:

First offense	- a fine of Five Hundred Pesos (P500.00)
Second Offense	- a fine of One Thousand Pesos (P1000.00)
Third offense	- a fine of Two Thousand Five Hundred Pesos (P2,500.00)

SECTION 5. REPEALING CLAUSE. All ordinance, resolution and executive orders or parts thereof, which are inconsistent with any of the provisions of this ordinance, are hereby repealed or modified accordingly.

SECTION 6. SEPARABILITY CLAUSE. If for any reasons, any part of provision of this ordinance hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 7. EFFECTIVITY. - This ordinance shall take effect immediately upon approval hereof.
