"MUNICIPAL ORDINANCE NO. 036 Series of 2017

AN ORDINANCE AUTHORIZING THE TEMPORARY ROAD CLOSURE OF A PORTION OF J. LUNA STREET ON SEPTEMBER 28, 2017 FOR THE 2ND ANNIVERSARY CELEBRATION OF BYKELINK MOTOR INC.

WHEREAS, Section 21 of the Local Government Code provides that:

- a) A local government unit may, pursuant to an ordinance permanently or temporarily close or open any local road, alley, park or square falling within its jurisdiction.."
- b) Any national or local road, alley, park or square may be temporarily closed during an actual emergency, or fiesta celebrations.. the duration of which shall be specified by the local chief executive concerned in a written order.."

WHEREAS, the Bykelink Motors, Inc. shall celebrate its 2nd anniversary on September 28, 2017; hence

WHEREAS, they are asking for a permission to close a portion of J. Luna Street for their activities scheduled on that day;

WHEREAS, to avoid inconvenience to the public and to ensure full implementation of rules and regulations on economic enterprise as well as on peace and order, there is a need to designate a specific place for these seasonal business activities;

WHEREFORE, on motion by Hon. George G. Diel and duly seconded by Hon. Permita B. Lamberto, be it

ENACTED, AS IT IS HEREBY ENACTED, BY THE SANGGUNIANG BAYAN OF TRENTO, AGUSAN DEL SUR, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, IN SESSION ASSEMBLED THAT:

Section 1. A portion of J. Luna St. is hereby declared temporarily closed to all vehicular traffic on September 28, 2017 starting from 7:00 o'clock in the morning to 5:00 o'clock in the afternoon.

Section 2. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval thereof.
