AN ORDINANCE IDENTIFYING A PORTION OF BLOCK 8, LOT 1 WITH A TOTAL AREA OF FOUR HUNDRED TWO SQM (402 SQM) LOCATED AT BARANGAY PULANGLUPA, TRENTO, AGUSAN DEL SUR BE INTENDED FOR THE CHILD DEVELOPMENT CENTER

WHEREAS, Day Care Service addresses the needs in the crucial stages of a child's growth;

WHEREAS, the LGU Trento implemented a project namely Child Development Center under 20% Local Development Fund;

WHEREAS, as to date, the project is 100% complete and eventually ready for its improvement, operation and maintenance;

WHEREAS, through donation, the project and its area will be improved and maintained by BLGU Pulanglupa, Trento, Agusan del Sur;

WHEREFORE, on motion by Hon. Permita B. Lamberto and duly seconded by Hon. Niño John J. Hontiveros,

Be it ordained by the Sangguniang Bayan in session assembled that:

Section 1. It is hereby identified that a portion of Block 8, Lot 1 with a total area of Four Hundred Two Square Meters (402 sqm) located at Trento Resettlement Project, Barangay Pulanglupa, Trento, Agusan del Sur be intended for the Child Development Center;

Section 2. Separability Clause. If, for any reason or reasons, any part or provision of this Ordinance shall be found unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and in effect.


Section 3. Repealing clause. -All ordinances, local issuances or rules inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

Section 4. Effectivity Clause. This Ordinance shall be effective upon approval thereof.


