AN ORDINANCE CREATING THE POSITIONS OF TWO ADMINISTRATIVE AIDE I WITH SALARY GRADE 1 IN THE OFFICE OF THE MUNICIPAL PLANNING AND DEVELOPMENT OF THIS MUNICIPALITY

Be it ordained by the Sangguniang Bayan in session assembled that:

Section 1. There is hereby created the plantilla positions for Two (2) Administrative Aide I (Utility Worker 1) with Salary Grade 1 in the Office of the Municipal Planning and Development of Trento, Agusan del Sur

Section 2. Qualifications for the said position shall be based on the standards set for the Civil Service Commission:


Section 4. Repealing clause. -All ordinances, local issuances or rules inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.
