AN ORDINANCE CREATING THE POSITIONS OF TWO ADMINISTRATIVE AIDE I WITH SALARY GRADE 1 IN THE OFFICE OF THE MUNICIPAL PLANNING AND DEVELOPMENT OF THIS **MUNICIPALITY**

Be it ordained by the Sangguniang Bayan in session assembled that:

Section 1. There is hereby created the plantilla positions for Two (2) Administrative Aide I (Utility Worker 1) with Salary Grade 1 in the Office of the Municipal Planning and Development of Trento, Agusan del Sur

Section 2. Qualifications for the said position shall be based on the standards set for the Civil Service Commission:

- Section 3. Separability Clause. If, for any reason or reasons, any part or provision of this Ordinance shall be found unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and in effect.
- Section 4. Repealing clause. -All ordinances, local issuances or rules inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.
- Section 5. Effectivity Clause. This Ordinance shall be effective upon approval thereof.
