ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 24-2017 FROM 50-50 SHARING SCHEME BETWEEN LGU- TRENTO AND BLGU- PULANGLUPA INTO 70-30 SHARING SCHEME IN FAVOR TO BLGU- PULANGLUPA OF THE GROSS COLLECTION FROM THE MUNICIPAL CEMETERY LOCATED AT BRGY. PULANGLUPA

WHEREAS, this amendment aims to give BLGU-Pulanglupa more shares considering that they are fully incharge in its cemetery's repairs, maintenance and preservation;

WHEREAS, the BLGU-Pulanglupa has yet to receive its share from the LGU Trento and thus given the authority to receive 70% Share from the start of its operation;

WHEREFORE, on motion by Hon. Edcil Marie P. Dagsan and jointly seconded by Hon. Niño John J. Hontiveros and Hon. Pricilla C. Cabusas, be it

Be it ordained by the Sangguniang Bayan of Trento, Agusan del Sur in session assembled that:

Section 1. Section 1 of Municipal Ordinance No. 024-2017 shall now be read as:

Section 1. A 70-30 Sharing Scheme of BLGU Pulanglupa and LGU Trento from the gross collections of municipal cemetery located in Barangay Pulanglupa, Trento, Agusan del Sur is hereby approved.

Section 2. Separability Clause. If for any reason or reasons, any part or provision of this Ordinance is held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

Section 3. Repealing Clause. All Ordinances, local issuances or rules inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

Section 4. Effectivity Clause. This ordinance shall take effect immediately upon approval.
