AN ORDINANCE CREATING THE POSITIONS OF NURSE 1 WITH SALARY GRADE 11, AND TWO (2) MIDWIFE 1 WITH SALARY GRADE 9 IN THE MUNICIPAL HEALTH OFFICE OF THIS MUNICIPALITY

Be it ordained by the Sangguniang Bayan in session assembled that:

Section 1. There is hereby created the plantilla positions for One (1) Nurse I with Salary Grade 11 and Two (2) Midwife I With Salary Grade 9 in the Municipal Health Office of Trento, Agusan del Sur:

Section 2. Qualifications for the said positions shall be based on the standards set for the Civil Service Commission:

Section 3. Separability Clause. If, for any reason or reasons, any part or provision of this Ordinance shall be found unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and in effect.

Section 4. Repealing clause. -All ordinances, local issuances or rules inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

Section 5. Effectivity Clause. This Ordinance shall be effective upon approval thereof.
