ORDINANCE AMENDING SECTION 2, SECTION 8 AND SECTION 12 OF MUNICIPAL ORDINANCE NO. 003-2013, AN ORDINANCE CREATING THE TRENTO LOCAL HOUSING BOARD DEFINING ITS POWER AND FUNCTIONS PURSUANT TO REPUBLIC ACT 7279 AND EXECUTIVE ORDER NO. 708 SERIES OF 2008 AND FOR OTHER PURPOSES

Be it ordained by the Sangguniang Bayan in session assembled that:

Section 1. TITLE. This ordinance is amending "The Ordinance creating Trento Local Housing Board

Section 2. AMENDATORY PROVISION. The following provisions of the Municipal Ordinance No. 003-2013 are hereby amended:

"Section 2 Composition: The Trento Local Housing Board which shall be hereinafter referred to as the Board, shall be composed of the following

Chairman

Municipal Mayor

Co-Chairman

SB Committee Chairperson on Housing and Land Use

Members

1. Municipal Planning and Development Coordinators

2. Municipal Engineer 3. Municipal Assessor

4. Municipal Budget Officer

5. Municipal Social Welfare and Development Officer

6. Chief of Police, Trento Police Station

7. President, Association of Barangay Captains (ABC)

8. Representative, Civil Society Organization (CSO)

Housing related organization accredited by the Sangguniang

Bayan

"Section 8. Meeting and Quorum. The board shall have a quarterly meeting except for a special meeting to be called by the Chairman. The presence of the Chairman/Co-Chairman and the majority of the members shall constitute a quorum to transact official business.

In the event that the Chairman or Co-Chairman is absent or in official business as long as majority of the members is present and can constitute quorum, the members who are present will select a member to preside the meeting.

"Section 12. Cooperation of Concerned Agencies. The Board shall coordinate with all concerned agencies such as the Department of Human Settlement and Urban Development (DHSUD), Department of Interior and Local Government (DILG), Philippine National Police (PNP), Department of Public Works and Highways (DPWH) Government –Owned and Controlled Corporations related in housing, Presidential Commission on Urban Poor (PCUP)

- Section 3. Separability Clause. If, for any reason or reasons, any part or provision of this Ordinance shall be found unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and in effect.
- Section 4. Repealing clause. -All ordinances, local issuances or rules inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

Section 5. Effectivity Clause. This Ordinance shall be effective upon approval thereof.
