AN ORDINANCE RECLASSIFYING LOT NO. 1581-B CSD-13-019592 UNDER TCT NO. 10059-2018000809 LOCATED AT SITIO ONOMAN, BRGY. PULANGLUPA, TRENTO, AGUSAN DEL SUR FROM AGRICULTURAL TO SPECIAL USE

WHEREAS, the Meilleur Group of Developers Corporation that is engaging in real estate business, is intending to establish and operate a memorial park in the Municipality of Trento;

WHEREAS, Lot No. 1581-B CSD-13-019592 under TCT No. 10059-2018000809 located at Sitio Onoman, Barangay Pulanglupa, Trento, Agusan del Sur is classified as agricultural zone;

WHEREAS, the aforementioned lot was proposed to be reclassified from agricultural to special zone in order to conform in the land uses;

WHEREAS, the proponent had submitted requirements specified by the Memorandum Circular No. 54 and Administrative Order 363 from the Office of the President for reclassification;

WHEREAS, upon verification, the said lot can be classified from agricultural to special zone;

NOW THEREFORE, BE IT ENACTED, AS IT IS HEREBY ENACTED, BY THE SANGGUNIANG BAYAN OF TRENTO, AGUSAN DEL SUR, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, IN SESSION ASSEMBLED THAT:

Section 1. This ordinance is reclassification of Lot No. 1581-B CSD-13-019592 under TCT No. 10059-2018000809 located at Sitio Onoman, Barangay Pulanglupa, Trento, Agusan del Sur from Agricultural to Special Zone, this municipality.

Section 2. Separability Clause. If, for any reason or reasons, any part or provision of this Ordinance shall be found unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and in effect.

Section 3. Repealing clause. -All ordinances, local issuances or rules inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

Section 4. Effectivity Clause. This Ordinance shall be effective upon approval thereof.
